I. Treasurer's Report.

Neighbors were encouraged to give Elizabeth \$40 in voluntary annual dues.

II. Elections

IV. Review of Peninsula construction and progress of stormwater pump station

Those attending asked and answered questions about road changes (Alumni lane markings at intersection of Squires were added due to traffic study); asbestos removal (yes, asbestos has been safely removed); about the buffer being displayed on the plat (we thought that it was shown); about the density of development on the Peninsula (which is supposed to be comparable to nearby neighborhood density); and that we are a watchdog of the Ball Homes development (neighbors are encouraged to report suspected violations).
